# C. Update from NORR and Review and discussion of Programming Study

- The pool should be evaluated as part of NORR's review.
- The Phase I Environmental Assessment should be reviewed.
- Given the age of the building, there may be asbestos in some of the building's materials.
- These evaluations will help inform the potential costs of the project.
