## **COMMUNICATION/DISCUSSION ITEM #1: Project Updates**

## a. Adams Park Project

PM Laird confirmed the project is on track and reviewed construction progress and photos.

- Screened fencing is up
- Electric meter is installed and utilities coordinated
- Two construction entrances are being used
- Grading is underway and will be ongoing
- Initial staking is complete
- Centerpiece Elm has been secured
- Project photos are online at Engage.bhamgov.org

## No Action was taken by the Parks and Recreation Board

#### b. Pickleball

PM Laird stated that the Request for Proposals (RFP) has been put together and is currently out to bid and bids are due on Thursday, July 14, 2022. There were eighteen (18) pages of vendors that were notified through the city's bidding agent MITN. PM Laird stated there are at least 10 – 12 vendors on a page, so several vendors were notified of the project with the project starting in September.

Specifications include:

- Remove existing nets
- Repair cracks
- Apply new acrylic surfacing and court markings
- Supply and install new pickleball nets
- Divide cells with new fencing

Update on proposals will be discussed during a future Board meeting.

DPS Director Wood stated that this project has not been previously put out for bid, but there are concept drawings available on Engage.Bhamgov.org.

PM Laird stated when the full six (6) court layout is available, the city will engage with Birmingham Racquet Club (BRC) to promote the program and possibly conduct a clinic.

Ultimately, the pickleball courts will be part of the city's court reservation system.

Carmona suggested that as we move forward we consider monitoring usage and conducting outreach with our local enthusiasts to gauge interest.

Rusche inquired about the project completion deadline, and PM Laird clarified that a September 30, 2022, deadline was communicated to participating vendors

but would consider other reasonable completion dates, if necessary. No Action was taken by the Parks and Recreation Board

## c. Dog Park Update

RC Folk provided the update on our dog park program that has been active for more than 11 years. Membership for the past fiscal year, ending June 30, 2022, included one hundred seventy-seven (177) active memberships with a net income of \$2,600. Annual expenses include the purchase of dog fobs, seeding in spring and fall, mowing, and fence maintenance.

Graham inquired about the forty percent (40%) increase in expenses, and RC Folk attributed to salary and wages, fencing and seeding.

Graham inquired about membership processes, and RC Folk described that access fobs can be activated / deactivated remotely and members are notified when their annual passes require renewal.

Collins stated she has visited the dog park with her sister and found the Lincoln Hills Dog Park to be a very social place.

RC Folk shared that she and PM Laird held an open house a couple of years ago to meet with users and get their feedback. Users were happy with the park and would welcome a future structure for shade.

SUBJECT: Sculpture Donation – "Khyber" by Tom Fitzgerald

The City of Birmingham has received a sculpture donation application for "Khyber" by Tom Fitzgerald. The sculpture was built in 1979 and consists of black painted steel that is 120'' high with a base that is  $54'' \times 50''$ .

The name "Khyber" comes from the Khyber Pass on the border of Afghanistan and Pakistan. An integral part of the Silk Road, this area has been a historically important pass bridging central and southern Asia, considered to be one of the most important trade routes and military strategic locations in the world.



On May 18<sup>th</sup>, 2022, the Public Arts Board discussed possible location for the sculpture. The top two suggestions were Linn Smith Park off of Southfield Road, just north of Lincoln Road, and the park area where Fairway Trail intersection with Fairway Drive. A suggestion was later received for the area next to the Chesterfield Fire Station.

On June 15<sup>th</sup>, 2022, the Public Arts Board considered the top three suggested locations and felt that the greenspace south of Fairway Trail was the best suitable location for the sculpture. The Board felt that the scenery of Fairway Trail would be an interesting sight to see through the opening of the sculpture and that the scale of the park would accommodate the perspective of the sculpture.


In regards to an exact location, staff agreed to meet with Board members at the park at a later date to narrow down a specific location to be presented to the Parks & Recreation Board and then City Commission. The Board motioned to recommend approval of the sculpture donation and for the sculpture to be placed in Fairway Park near Fairway Trail.

On July 7<sup>th</sup>, staff walked the park with Annie VanGelderen of the Public Arts Board and BBAC and selected the location for the sculpture. Mrs. VanGelderen thought it would be best to have the sculpture closer to the trail where it bends and get closer to the stream.

#### Recommended Action:

Motion to recommend the location of Fairway Park indicated in Exhibit A for the installation of the Sculpture "Khyber" by Tom Fitzgerald.



SUBJECT: Crestview Park Pickleball Courts Recommendation

#### INRODUCTION:

Pickleball Courts is a priority project as part of the Parks and Recreation Bond. At the April 2022 Parks and Recreation meeting, it was determined that the location of Pickleball Courts would be Crestview Park, by way of a conversion of the existing tennis courts to Pickleball.

#### BACKGROUND:

Since the approval of the Parks and Recreation Bond, we've been working to determine the best location for Pickleball courts in the City. Five potential locations were presented and evaluated, narrowed to three. The top three locations for Pickleball courts were Crestview Park, Kenning Park, and St. James Park. Public input was received at the Parks and Recreation Board level and through engage Birmingham throughout this process.

While new construction courts at Kenning Park was the original recommendation in December of 2021, numerous challenges contributed to the delay in the ability to move forward with this location including: the availability of Parks and Recreation Bond funding (other Bond projects costing higher than anticipated), the design consultant withdrew services, and the Kenning Park location revealing a number of potential conflicts with future projects.

Pickleball courts can be accomplished using a tennis court conversion method as an alternative to new construction at a lesser cost. Crestview Park was selected for a court conversion by considering factors such as available on street parking, lower number of reservations for tennis compared to other tennis courts, room for six Pickleball courts, a shady area next to the court to provide seating, current park activity levels, no directly adjacent homes located next to the courts or in other words, there is a street barrier between the courts and residences, and no conflicts with future projects.

In order to provide Pickleball courts more immediately rather than waiting for this project to go through our required procurement process, staff was directed by the City Commission at the May 23, 2022 meeting to have lines painted on top of the Crestview Tennis courts in order to offer Pickleball courts in lieu of tennis as a temporary measure

(two courts) while we move forward with an RFP for the correct conversion according to USA Pickleball Association (six courts).

A RFP for Crestview Park Pickleball courts was posted to MITN on June 17, 2022 with a deadline for proposals by July 14, 2022. The scope of work for this project is to perform a complete conversion of the existing two tennis courts to six pickleball courts at Crestview Park. The project includes the removal of the tennis nets and posts, crack repair and the application of new acrylic surfacing over the entire existing court surface, the supply and installation of new pickleball posts and nets for six courts, new 8' fencing to separate three northern courts from three southern courts, new markings for six pickleball courts and all related work. Additionally, an alternate for an addition of a sound reducing fence material was included. Lastly, a project completion deadline of September 30, 2022 was requested.

One bidder responded. Goddard Coatings Company provided a proposal of \$63,750.00 for this project. They did not provide a proposal for the alternate fence. In addition, they did not commit to completion by September 30, 2022 due to a backlog of work and committed schedules, however described in their proposal they will do their best to meet such deadline.

#### LEGAL REVIEW:

The City Attorney has reviewed the RFP and has no concerns. A review of the agreement with Goddard Coating is underway and will be finalized before recommendation to the City Commission.

#### FISCAL IMPACT:

This project will be a part of the Parks and Recreation Bond funding.

#### SUMMARY:

The Department of Public Services recommends awarding the Crestview Park Pickleball Courts project to Goddard Coatings Company. They are a qualified contractor, members of the American Sports Builders Association, and have performed crack repair and new surfacing projects for the city in the past. Goddard Coatings has performed court installations and surfacing projects for numerous municipalities, private clubs, schools, and condominiums throughout Michigan. While they may not meet our requested date of September 30, 2022, they will do their best to accomplish this project in the fall of 2022. The department will look into the sound barrier fence material as a separate purchase. We have no costs at this time.
