## MAINTENANCE TECHNICIAN (Temporary)

### Description

The City of Birmingham (EOE) is immediately seeking a temporary Maintenance Technician to perform a wide variety of duties related to building maintenance, security, and preventative maintenance programs at City Hall, the Baldwin Library, and other municipal facilities. Duration: Until October 2017, with possible extension.

The Maintenance Technician is also responsible for HVAC seasonal and preventative maintenance programs. Assists the Building Superintendent in administering contracts for repair and maintenance; performs a variety of miscellaneous errands and duties for the efficient operations of City Hall and other departments:

- Monitors and evaluates the work result of contracted custodial services; notes and follows up with contractor on problems as they arise. Performs occasional custodial duties as required in individual situations.
- Picks up and delivers City Hall mail from/to the Post Office. Assists individual departments with special mail deliveries. Receives and picks up supplies and materials for operations; may assist in receiving for individual departments. Collects and transports recycled paper, etc. for City Hall recycling program.
- Replaces lamps in overhead lights; makes minor repairs. Performs minor plumbing, carpentry, electrical repairs, and interior painting.
- Prepares rooms in various facilities for meetings. Moves furniture and equipment upon request of individual departments.
- Performs related duties as assigned.

### Minimum Requirements

- Possession of a high school diploma, or its equivalent, with coursework in mechanical or trades areas.
- At least three (3) to five (5) years of general building maintenance duties with specific knowledge and experience in automated HVAC systems.
- Valid State of Michigan Driver's license, with a satisfactory driving record.
- Ability to communicate and collaborate with a diverse range of individuals in carrying out assigned duties, and exhibit a courteous demeanor with excellent customer service and interpersonal skills.
- Ability to safely operate mechanical equipment; ascend/descend 12-ft ladder; stand/walk for long periods of time; lift arms above head (i.e. change light bulbs, store items, etc.); lift up to 50 pounds.
